Please refer to your letter No. 16 (3)/94-Admin/118 dated January 17, 2003 regarding the subjected matter. Matter has been conveyed to our Head Office and the competent authority is pleased to extend Medical facilities for the dependents of employees annexed in your above referred letter. The arrangement will be regulated as per the following guide lines.

1. The dependents of the employees of the Monazite Survey Project, Kollam, will be provided with medical consultations by our Company Doctors for the preliminary treatment and any medicines being supplied to them by our IREL Dispensaries/Hospitals has to be charged to BARC for reimbursement.
2. In case of any major medical treatment, our Doctors can refer the dependents to Rare Earths Division's referral Hospitals for treatment as being done for our own employees. Necessary co-ordination/authorisation letters etc. be provided by our Company Doctor. The expenditure in connection with such treatment are to be settled by Rare Earths Division and ultimately reimbursed by BARC.

The employees concerned may be asked to report to our Chief Medical Officer in order to submit the medical declaration of their eligible members.
