
From this year onwards Online facility is made available through Anunet link [daeaward.anunet.in](http://daeaward.anunet.in) for submitting the award proposals (except Lifetime Achievement Award, Exceptional Service Award and Special Contributions Award).

The nominations submitted under individual category for the year 2015 & 2016 (which are eligible to be carried over for another two years) and Group Achievement Award for the year 2016 (which are eligible to be carried over for another one year) are also required to be updated by incorporating the latest resume of work, achievements and publications for the preceding five years (i.e. upto to the latest APAR period).

All nominations should be approved by concerned Unit Head / Group Director as indicated in the brochure. No vigilance case should be pending against the nominated person. Vigilance clearance in respect of the nominee/s (individual, Group Leaders & members) must be obtained from the concerned Vigilance Section and should be uploaded into the online award system before final submission of the nomination. If a case is initiated after submission of the nomination, the same should be intimated to Secretary, TC/TSC, BARC immediately.

DAE, Unit Heads and Group Director/Associate Director/Division Heads of BARC may send the Employee Number, Name, Designation, Division, Contact No. and Email ID to [awardcell@barc.gov.in](mailto:awardcell@barc.gov.in) on or before **23<sup>rd</sup> March 2018** for creation of User ID and password for uploading the nominations. Approval of Unit level/Group level should be obtained before uploading the nominations. Proposals sent manually, other than categories viz. Lifetime Achievement Award, Exceptional Service Award and Special Contributions Award, shall not be considered.

After successful online submission Nomination Form duly signed by *Proposer / Divn. Head / Group Director / Unit Head* should reach Award Cell, BARC on or before **30<sup>th</sup> April, 2018**. The nominations not conforming to the prescribed format/instructions will not be accepted. Hard copy and CD of the nomination for Lifetime Achievement Award, Exceptional Service Award and Special Contributions Award should also reach Award Cell, BARC by 30<sup>th</sup> April, 2018.
