Sub:Contributory Health Service Scheme CHSS)
of the Department of Atomic Energy Maxtension to cover medical attention
and treatment under the Ayurvedic and
Homeopathic systems of medicines.

In this Department's O.M.No.32(5)/69-Adm. dated April 21,1975 a revised Contributory Health Service Scheme (CHSS) was introduced in the Department of Atomic Energy with effect from May 1, 1975. The benefits under the scheme were so far restricted to the Allopathic (modern) system of medicine only.

- The CHSS of the Department will, with effect from October 2, 1985 cover medical attention and treatment under Ayurvedic & Homeopathic systems of medicines also. For this purpose the details of the scheme as contained in paras 5,6,8 and 12 will apply with the following modifications:
- 5.1 The treatment shall be provided in Smt, Mahadevi Anandibal Podar Ayurvedic Hospital, Worli, Bombay-400018, and Government Homeopathic Hospital, Irla Naka, Vile Parle, Bombay-400 056, and this Ayurvedic and Homeopathic treatment will not be available from the Department's Dispensaries.
- 5.2 (a) Resident Medical Officer, Mahadevi Anandibal Podar
 Ayurvedic Hospital and the Administrative Medical
 Officer, Government Homeopathic Hospital are declared
 as Authorised Medical Officers under C.S(MA) Rules, 1944
 for Ayurvedic and Homeopathic freatment respectively
 mentioned in paragraphic above.

- (b) The beneficiaries will be issued with a reference letter by the Heads of Office of the concerned Units where they are working, on a specific request of the beneficiary concerned showing the monthly income of the beneficiary. Apart from this, the beneficiaries will have to produce CHSS cards issued by the Department for Allopathic treatment. They will also produce their respective CHSS cards to the Authorised Medical Officers of the following hospitals/dispensaries recognised under the Scheme at the time of attending the OPD or at the time of admission:
 - i) Smt.M.A.Podar Ayurvedic Hospital, Worli, Bombay-400 018.
 - ii) Government Homeopat ic Hospital, Irla Naka, Vile Parle, Bombay-400 056.
- (c) The Authorised Medical Officers will be paid a monthly honourarium of Rs. 300% which may be revised from time to time. Revised who for vide Dat In M. 7/12/195- CHS/M. Po/110 & 7/4/2009
- 6.1 For hospitalise ion treatment under the Ayurvedic/Homeopathic systems at the Government Hpspitals, the beneficiaries will be required to bear the charges initially at the time of attending O.P.D or at the time of admission and they could seek reimbursement from units where they are working as per C.S(MA) Rules, 1944,
- 8.1 No specialists are provided for consultation under both the above systems.
- 2.1 On the prescriptions of Authorised Medical Officers recognised under this extended scheme, the medicines usually stocked in the hospital will be supplied and the charges as prescribed in the hospital Fee Rules will be recovered. The medicines which are not stocked will have to be purchased by the patient and the entire amount may be reimbursed by the respective units of the beneficiaries concerned, on the basis of the prices indicated in the catalogues of the pharmacies concerned.

- 12.2. In cases where the charges for medicine are more than the rates approved in the CSMA Rules, 1944 the excess
- & charges will have to be made by the beneficiaries. In the case of restricted and costly medicines as specified
- 12.3. in Annexure-I of Para-II (Schedule-3) of CSMA Rules,
 the claims for reimbursement are to be countersigned by
 the Director of Ayurveda, Maharashtra State, Bombay and
 the Deputy Director of Ayurved (Homeopathy) Bombay, for
 the Ayurvedic and Homeopathic treatment respectively.
- 3. The beneficiaries of specialist treatment and special facilities in the institutions outside Bombay contemplated under para 7 to 9 of the scheme will not be applicable for the extended scheme under indigenous and Homoepathic systems of medicines.
- 4. The expenditure on the extension of the scheme to cover treatment under the Ayurvedic and Homoepathic systems of medicines will be debited to the respective budget heads of the Department and Units where the employees are working.
