OFFICE MEMORANDUM

Sub : Contributory Health Service Scheme
for officers & staff of the Deptt.
of Atomic Energy stationed at Bombay.

....

It has been decided to amend the Contributory Health Service Scheme applicable to the employees of the Department of Atomic Energy stationed at Bombay introduced vide O.M. No.32/5/69-Adm. dated April 21, 1975 to the extent indicated below :

Clause 2.1.(2) : Shall be read as under :-

" The employees of the Department including work-charged/fixed term employees (other than the casual staff and the staff paid from the contingencies) stationed at Bombay and members of their families residing with them ".

NOTE : The Scheme may be extended at the discretion of the Department to the staff paid from contingencies who are stationed at Bombay.

Clause 8.5 : The second sentence of existing clause 8.5 shall be substituted by the following sentence :-

" Reimbursement of expenses on spectacles free of charge upto Rs.50/- subject to production of cash receipt to the employees whose pay does not exceed Rs.480/- p.m.

Clause 10.4 :

" Maternity benefits under clause 10.4 confinement charges shall be revised on the following scale.

Clause 14.5 : The amount admissible for hiring hearse has been increased to Rs.50/- and may be reimbursed to the employees in Category A & B (vide Annexure I) only.

Clause 15.8 : This clause to be deleted and further clauses renumbered.

Clause 17 : The following shall be added under clause 17.3

" Head, Medical Division, BARC may relax these limits in case of serious illness."
