OFFICE MEMORANDUM

Subject: Contributory Health Service Scheme (CHSS) -
reintroduction of the reciprocal arrangement
between the Department of Space and Department
of Atomic Energy - reg.

1.1 The undersigned is directed to refer to this department's Office Memorandum of even number dated March 29, 1993, withdrawing the reciprocal arrangement of Contributory Health Service Scheme between the Department of Space and the Department of Atomic Energy. In view of the difficulties expressed by the Department of Atomic Energy consequent to the withdrawal of the CHSS reciprocal arrangement, the matter has been reconsidered, and it has since been decided to reintroduce the CHSS reciprocal arrangement between DOS and DAE retrospectively with effect from 01.04.1993. Accordingly, the employees, both serving and retired, of the Department of Atomic Energy stationed at Bangalore, Ahmedabad and Hassan will now be eligible for the CHSS of the Department of Space with effect from 01.04.1993 as per DOS Office Memoranda No. 9/1(8)/77-IV dated May 24, 1977, and No. 3/1(9)/84-IV dated September 10, 1985.

1.2 Similarly, the employees, both serving and retired, of the Department of Space, stationed at Bombay, Tarapur, Kota and Talcher, will also be eligible for the CHSS of the Department of Atomic Energy with effect from 01.04.1993.

2. Since the reintroduction of the CHSS coverage is retrospectively from 01.04.1993, the contribution from the employees, both serving and retired, should also be from 01.04.1993. Accordingly, the Units of both DOS and DAE shall recover the contributions from their employees, both serving and retired, with effect from 01.04.1993.

3. The expenditure incurred by one Department on behalf of the other in this connection shall be booked directly to the major/minor head of account of the other.
